



OPTIONS RELATED TO AT-NEED PAYMENT

Because we understand that the expense of caring for the death of a loved one is often unexpected and unplanned, we offer choices in which you may fulfill your financial commitment. We are confident you will find one or a combination of the following options that best suits your individual circumstances and needs. Sweet's Funeral Home does require that all expenses be secured by one or more of the following payment methods prior to the date of service.

OPTION ONE:

Many families prefer to pay for their total expenses at the time of service arrangements or at the conclusion of services rendered. We accept cash, personal checks, cashier's checks, and all major credit cards. We require a minimum 50% deposit (not including cash advances) with the balance due in 30 days. If the balance remains unpaid beyond the due date, a late charge of 1.25% per month (15% per annum) may be added to the unpaid portion. ***If the balance remains unpaid for 60 days beyond the due date, your overdue account will be turned over to our collection service and you will be responsible for all costs and attorney's fees incurred.***

OPTION TWO:

Another common method used for payment is assignment of the proceeds of insurance policies. As a service to those who choose to pay utilizing this payment method, we will assist you in the claims process required by your insurance provider. We offer this service at no additional cost to our families.

OPTION THREE:

Families sometimes ask if the funeral expenses can be paid from the assets of the estate of their family member. Due to the difficulty in predicting with exactness the time required for probate and eventual settlement of an estate, we are limited in our ability to accept this form of security on an account. We have found that it is often best for a family member(s) to settle the account with the funeral home and apply for reimbursement from the estate.
